Uncharted Shores Academy based the ESSER III funding on the priorities listed in the LCAP and a continuance of the measures implemented in the Expanded Learning Opportunity Grant. Both of these documents contributed to the development of the ESSER III plan. As such, we included the input of community members that we consulted with during the development of the LCAP during 20-21, which addressed the needs of low income students, migrant, foster youth, English learners, homeless, and students with diabilities. The LCAP document link is included in this report for reference. Additionally, an open hearing was held during the October 2021 Board meeting to give additional opportunities for public input. The ELO was also developed with input from stakeholders, and a link to the ELO is also included for reference.

Consideration was given to all entities who attended the meetings, and the general consensus of opinion was carried out in the actual plan for the use of the funds. All individuals agreed that using the funds for the benfit of all students was of paramount importance so that all

needs would be met, and a whole school plan was utilized in the development of the plan. Community and the USA Governing Board both agreed to adding the grant to fill in additional funds in already existing actions in the current LCAP plan.

# **ESSER III Expenditure Plan Instructions**

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
